Master Class: \$120/hr +travel and expenses (includes a professional assistant)

\*To ensure my pieces and classes are interpreted, executed and properly inspired, I will almost always have an assistant. My assistants are adult, working dancers, who have been trained by me and in my teaching style, therefor I pay them a professional rate.

\*\*In some instances, it may be appropriate or necessary to use an in-house assistant. In this case, I may choose to discount or waive my assistant fee.

Gas- Standard Federal Rate

Airfare- Covered or Reimbursed by Studio

Food- \$40/day

Hotel Accommodations- Covered or Reimbursed by Studio
